Dear Shareholder

Notice of 2021 Annual General Meeting of Shearwater Group plc (the “Company”)

The 2021 Annual General Meeting (“**2021 AGM**”) of the Company is to be held at 11.00am on Wednesday 22 September 2021 at the offices of Mayer Brown International LLP, 201 Bishopsgate, London EC2M 3AF. The notice convening the 2021 AGM is set out on pages 5 to 8 of this document.

At the time of publication of this notice convening the 2021 AGM, it is anticipated that the 2021 AGM will proceed as an open meeting. The Board of Directors of the Company are keen to welcome shareholders of the Company (“**Shareholders**”) in person to the 2021 AGM, particularly given the constraints we faced in 2020 due to the COVID19 pandemic. However, given ongoing uncertainty, and bearing in mind the broader public health considerations and for the safety of others, any Shareholders wishing to attend the 2021 AGM in person are asked to register their intention to do so as soon as possible and by no later than 5.00pm on Monday 20 September 2021, by emailing shearwater@almapr.co.uk. Any such communication will not provide a guarantee of admittance to the 2021 AGM where to do so would be in breach of any official guidelines governing public gatherings at the time and/or the need to protect the health and safety of those already in the meeting. We will continue to monitor government guidance in relation to the COVID19 pandemic, and if any changes to the arrangements set out in this document are required, we will communicate these via a regulatory information service and the Company’s website.

Shareholders will be asked to approve 8 resolutions at the meeting. Resolutions 1 to 5 represent routine business of the Company at its Annual General Meeting and require an ordinary resolution, that is, are required to be approved by Shareholders who together represent a simple majority of the ordinary shares in the Company present and voting (whether in person or by proxy) at the meeting. Resolutions 6 to 8 represent special business of the Company. Resolution 6 requires an ordinary resolution to be passed, and Resolutions 7 and 8 require special resolutions to be passed, that is, are required to be approved by Shareholders who together represent 75% of the ordinary shares in the Company present and voting (whether in person or by proxy) at the meeting.

The resolutions are summarised below:

Resolutions 1 and 2 – Accounts and Directors’ remuneration report

The Directors will present to the meeting the audited accounts and the Directors’ and auditor’s reports (which includes the Directors’ remuneration report) for the financial year ended 31 March 2021 (“**2021 Annual Report**”). Resolution 1 asks that the 2021 Annual Report be received by Shareholders. Resolution 2 asks that the Directors’ remuneration report be approved on an advisory vote.

Resolution 3 – Re-election of David Williams

The Company’s Articles of Association (the “**Articles**”) provide that each Director shall retire and is eligible for election or re-election at the Annual General Meeting held in the third calendar year following his last appointment, election or re-election. Accordingly, David Williams will retire immediately prior to the 2021 AGM and will offer himself for re-election as a Director at the 2021 AGM.

Resolutions 4 and 5 – Appointment and remuneration of auditors

It is the Company’s practice that its auditors are appointed at every Annual General Meeting of Shareholders at which accounts are presented. The current appointment of BDO LLP as the Company’s auditors will end at the conclusion of the 2021 AGM. The Company proposes to appoint BDO LLP as its auditors for the year ended 31 March 2022 and BDO LLP has advised the Directors of its willingness to stand for appointment. Resolution 4 proposes to appoint BDO LLP as auditors of the Company. In addition, it is the Company’s normal practice for the Directors to be authorised to agree how much the auditors should be paid and Resolution 5 grants this authority.

Resolution 6 – Issues of share capital

The authority conferred on the Directors at the Annual General Meeting held on 24 September 2020 to allot shares or to grant rights to subscribe for, or convert any security into, shares in the share capital of the Company expires at the end of the 2021 AGM.

Paragraph (a) of this resolution will, if passed, renew the Directors’ authority to allot shares, or grant rights to subscribe for, or convert any security into, shares up to an aggregate nominal amount of £793,657.96. This amount represents approximately 33.33% of the Company’s existing issued ordinary share capital (excluding treasury shares) as at 26 August 2021 (being the last practicable date before publication of the notice of the 2021 AGM).

Paragraph (b) of this resolution will, if passed, renew the Directors’ authority to allot further of the Company’s unissued shares in connection with a pre-emptive offer to existing shareholders by way of a rights issue up to an aggregate nominal amount of £1,587,315.93. This amount represents approximately 66.67% of the Company’s existing issued ordinary share capital (excluding treasury shares) as at 26 August 2021 (being the last practicable date before publication of the notice of the 2021 AGM). This amount would be reduced by the aggregate nominal value of any allotments or grants under paragraph (a) of this resolution. This is in accordance with the most recent institutional guidelines.

These authorities will expire at the end of the next AGM of the Company after this resolution is passed or, if earlier, at the close of business on 21 December 2022. The Directors intend to seek renewal of these authorities at future AGMs.

Resolution 7 – Disapplication of statutory pre-emption rights

This special resolution will, if passed, renew the power conferred on the Directors at the Annual General Meeting held on 24 September 2020 to allot ordinary shares, or grant rights to subscribe for, or convert securities into, ordinary shares, or sell treasury shares in each case for cash without first offering those shares to existing shareholders. Other than in connection with a rights issue or any other pre-emptive offer concerning equity securities, the authority contained in this resolution will be limited to the issue of shares for cash up to an aggregate nominal value of £238,097.39. This amount represents 10% of the nominal value of the Company’s issued ordinary share capital (excluding treasury shares) as at 26 August 2021 (being the last practicable date before publication of the notice of the 2021 AGM). This includes the sale on a non pre-emptive basis of any shares held in treasury.

The Directors have no present intention of exercising this power but believe it is in the interests of Shareholders for the Directors to have this flexibility to allot shares for cash and to sell treasury shares for cash in those limited circumstances in line with the Company’s strategy.

This power will expire at the end of the next AGM of the Company after this resolution is passed or, if earlier, at the close of business on 21 December 2022. The Directors intend to seek renewal of this authority at future AGMs.

Resolution 8 – Purchase of own shares

The authority conferred on the Directors at the Annual General Meeting held on 24 September 2020 for the Company to make market purchases of its own ordinary shares expires at the end of the 2021 AGM.

The Directors have no present intention of exercising the power to purchase any of the Company's ordinary shares but consider it prudent to retain their ability to do so. The Directors will only exercise the authority if they are satisfied that this is, in their opinion, in the best interests of the Company and Shareholders generally.

If these purchases were made, the Company would be able to do either or a combination of the following:

- a) cancel the purchased ordinary shares so reducing the total number of ordinary shares in issue; or
- b) where the shares were purchased out of distributable profits, subject to certain limitations, hold them as treasury shares.

Treasury shares themselves may be cancelled, sold for cash or transferred for the purposes of the Company's employee share schemes. The statutory pre-emption rights apply to a sale of treasury shares for cash and the disapplication of the statutory pre-emption rights in Resolution 7 applies to any sales of treasury shares for cash which may occur.

This resolution, which will be proposed as a special resolution, authorises the Directors to purchase up to a maximum of 2,380,973 ordinary shares, being approximately 10% of the issued share capital of the Company as at 26 August 2021 (being the last practicable date before publication of the notice of the 2021 AGM). This resolution provides that the maximum price per ordinary share payable on any exercise of the authority shall not be more than the higher of:

- a) an amount equal to 105% above the market value of an ordinary share for the five business days prior to making any purchase; and
- b) the higher of the price of the last independent trade of an ordinary share and the highest current independent bid for an ordinary share as derived from the trading venue where the purchase is carried out.

The minimum price payable shall be not less than 10 pence per ordinary share, being the nominal value of an ordinary share. For this purpose, both the maximum and minimum prices permitted to be paid are exclusive of expenses.

This authority will expire at the end of the next AGM of the Company after this resolution is passed or, if earlier, at the close of business on 21 December 2022. The Directors intend to seek renewal of this authority at future AGMs.

Action to be taken

You will find enclosed with this document a form of proxy (the "Form of Proxy") for use in connection with the 2021 AGM. Whether or not you are able to attend the 2021 AGM, you are requested to complete the Form of Proxy and return it to the Company's registrars, Neville Registrars at Neville House, Steelpark Road, Halesowen B62 8HD so as to arrive as soon as possible but in any event not later than 11.00am on Monday 20 September 2021.

The return of the appropriate Form of Proxy will not prevent you from attending the 2021 AGM and voting in person if you are entitled to do so and so wish.

If the Form of Proxy is not completed and returned by 11.00am on Monday 20 September 2021 your vote at the 2021 AGM will not count.

Shareholders who wish to appoint a proxy are recommended to appoint the Chairman of the meeting as their proxy. In light of the uncertainty around whether any restrictions on attendance may be in place at the time of the meeting, if a Shareholder appoints someone other than the Chairman of the meeting as their proxy, that proxy may not be able to attend the meeting in order to cast that Shareholder's vote.

We recognise that, in light of the ongoing uncertainty relating to the COVID19 pandemic, Shareholders may not have the opportunity to attend and to ask questions at the 2021 AGM. Should a Shareholder have a question that they would have raised at the 2021 AGM had it been possible for them to attend in person, the Company asks that it be sent to shearwater@almapr.co.uk.

Recommendation

The Directors consider that each of the proposed resolutions to be considered at the 2021 AGM are in the best interests of the Company and Shareholders as a whole. Accordingly, the Directors recommend that you vote in favour of them as each of the Directors intends to do in respect of their own beneficial holding of shares in the Company, which, as at 26 August 2021 (being the latest practicable date before publication of the notice of the 2021 AGM) amount in aggregate to 3,974,983 ordinary shares representing approximately 16.7% of the existing issued ordinary share capital of the Company.

Notice is hereby given that the 2021 Annual General Meeting ("2021 AGM") of Shearwater Group plc will be held at the offices of Mayer Brown International LLP, 201 Bishopsgate, London EC2M 3AF on 22 September 2021 at 11.00am for the following purposes:

As ordinary business to consider and, if thought fit, pass Resolutions 1 to 5 inclusive which will be proposed as ordinary resolutions.

- 1) To receive the Directors' and auditor's reports and the financial statements for the year ended 31 March 2021.
- 2) To approve the remuneration report for the year ended 31 March 2021 on page 51 of the Directors' report.
- 3) To re-elect David Williams who retires as a Director and, being eligible, offers himself for re-election as a Director at the 2021 AGM.
- 4) To re-appoint BDO LLP as auditors to the Company to hold office until the conclusion of the next Annual General Meeting of the Company.
- 5) To authorise the Directors to determine the auditor's remuneration.

As special business to consider and, if thought fit, pass the following resolutions of which Resolution 6 will be proposed as an ordinary resolution and Resolutions 7 and 8 will be proposed as special resolutions:

- 6) THAT the Directors are generally and unconditionally authorised for the purpose of s551 Companies Act 2006 to allot shares in the Company or to grant rights to subscribe for or to convert any security into shares in the Company ("**Rights**"):
 - a) up to a maximum aggregate nominal amount of £793,657.96; and
 - b) comprising equity securities (as defined in s560 Companies Act 2006) up to an aggregate nominal amount of £1,587,315.93 (that amount to be reduced by the aggregate nominal amount of shares allotted or Rights granted under paragraph (a) of this resolution) in connection with an offer by way of a rights issue:
 - i) to ordinary shareholders in proportion (as nearly as may be practicable) to their existing holdings; and
 - ii) to holders of other equity securities as required by the rights attaching to those securities, or subject to those rights, as the Directors otherwise consider necessary,

and so that the Directors may impose any limits or restrictions and make any arrangements which they consider necessary or appropriate to deal with treasury shares, fractional entitlements, record dates, legal, regulatory or practical problems in, or under the laws of, any territory or any other matter.

These authorities shall expire (unless previously renewed, varied or revoked) at the end of the next Annual General Meeting of the Company after this resolution is passed or, if earlier, at the close of business on 21 December 2022 but, in each case, so that the Company may make offers and enter into agreements before that expiry which would, or might, require shares to be allotted or Rights to be granted after that expiry and the Directors may allot shares or grant Rights pursuant to any of those offers or agreements as if the authority had not expired.

- 7) THAT, in substitution for all existing powers and subject to the passing of Resolution 6, the Directors are generally empowered pursuant to s570(1) Companies Act 2006 to allot equity securities (as defined in s560 Companies Act 2006) for cash pursuant to the general authority conferred on them by Resolution 6 as if s561(1) Companies Act 2006 did not apply to that allotment.

This power:

- a) shall be limited to the allotment of equity securities in connection with an offer of equity securities (but in the case of an allotment pursuant to the authority in Resolution 6(b) by way of a rights issue only):
 - i) to ordinary shareholders in proportion (as nearly as may be practicable) to their existing holdings; and
 - ii) to holders of other equity securities as required by the rights attaching to those securities, or subject to those rights, as the Directors otherwise consider necessary,

and so that the Directors may impose any limits or restrictions and make any arrangements which they consider necessary or appropriate to deal with treasury shares, fractional entitlements, record dates, legal, regulatory or practical problems in, or under the laws of, any territory or any other matter;

- b) shall be limited to the allotment of equity securities for cash pursuant to the authority in Resolution 6(a) (otherwise than in the circumstances set out in paragraph (a)) up to an aggregate nominal amount of £238,097.39.

These authorities expire (unless previously renewed, varied or revoked) at the end of the next Annual General Meeting of the Company after this resolution is passed or, if earlier, at the close of business on 21 December 2022 but so that the Company may make offers and enter into agreements before that expiry which would, or might, require equity securities to be allotted after that expiry and the Directors may allot equity securities pursuant to any of those offers or agreements as if this power had not expired.

These authorities apply in relation to a sale of shares which is an allotment of equity securities by virtue of s560(3) Companies Act 2006 as if in the first paragraph of this resolution the words "pursuant to the general authority conferred on them by Resolution 6" were omitted.

For the purposes of this resolution, references to the allotment of equity securities shall be interpreted in accordance with s560 of the Companies Act 2006.

- 8) THAT the Company is generally and unconditionally authorised for the purposes of s701 Companies Act 2006 to make one or more market purchases (within the meaning of s693(4) Companies Act 2006) of ordinary shares in its capital provided that:
- a) the maximum aggregate number of ordinary shares authorised to be purchased is 2,380,973;
 - b) the minimum price (excluding expenses) which may be paid for an ordinary share is not less than 10 pence;
 - c) the maximum price which may be paid for an ordinary share is in respect of an ordinary share contracted to be purchased on any day, not more than the higher of:
 - i) an amount (excluding expenses) equal to 105% of the average of the middle market quotations for an ordinary share as derived from the London Stock Exchange plc's Daily Official List for the five business days immediately preceding the day on which the ordinary share is contracted to be purchased; and
 - ii) an amount (excluding expenses) equal to the higher of the price of the last independent trade of an ordinary share and the highest current independent bid for an ordinary share as derived from the trading venue where the purchase is carried out; and
 - d) this authority expires at the end of the Company's next Annual General Meeting after this resolution is passed or, if earlier, at the close of business on 21 December 2022 but the Company may make a contract of purchase of any ordinary shares which would, or might, be concluded wholly or partly after that expiry and may make a purchase of ordinary shares pursuant to such a contract as if this authority had not expired.

- a) Only those shareholders entered on the relevant register of members of the Company at 11.00am on 20 September 2021 will be entitled to attend or vote at the 2021 AGM in respect of the number of shares registered in their name at the time. Changes to entries on the relevant register after that deadline will be disregarded in determining the rights of any person to attend or vote at the 2021 AGM. Should the 2021 AGM be adjourned to a time not more than 48 hours after the deadline, the same deadline will also apply for the purpose of determining the entitlement of members to attend and vote (and for the purpose of determining the number of votes they may cast) at the adjourned AGM. Should the 2021 AGM be adjourned for a longer period, then to be so entitled, members must be entered on the Register at the time which is 48 hours before the time fixed for the adjourned AGM or, if the Company gives notice of the adjourned AGM, at the time specified in the notice.
